ORDER

As per paper read (1 to 4) above, 4 pharmacy colleges namely Elims College of Pharmacy, Villadam, Thrissur, DM WIMS College of Pharmacy, Meppadi, Wayanad, Mookambika College of Pharmaceutical Sciences & Research, Mannathur, Ernakulam, St. Johns College of Pharmaceutical Sciences & Research, Kattapana, Idukki were given Continuation of Provisional affiliation to conduct B. Pharm course with 50 seats each for the academic year 2018-19. However the Hon'ble High Court, vide orders read (5) above in Writ Petitions filed by the above colleges, has decreed that the claim of the petitioners for enhancement of 10 seats doesn't require any fresh application as an increased intake to 60 seats will not make any difference as far as the University is concerned for granting renewal where the infrastructural facilities for the intake of 50 seats and 60 seats are one and the same.

- 2. AICTE has revised their norms and issued approval orders with an intake of 60 seats for B.Pharm course to the above mentioned colleges during the year 2018-19. As per approval process hand book of AICTE 2018-19 there is a batch of maximum of 60 seats in UG and diploma in pharmacy programme inclusive of supernumerary seats if any. The above colleges submitted approval orders from AICTE and PCI for the academic year 2018-19 for B.Pharm course with an intake of 60 seats.
- 3. Consequently 49th Governing council vide agenda item 40 decided to grant Provisional affiliation for enhancement of seats of B.Pharm course from 50 to 60 in the above mentioned colleges considering the Hon'ble High Court's orders and the norms of AICTE.As per decision read (7) above GC ratified the action of University in granting Continuation of Provisional Affiliation to B.Pharm course by revising the already issued order mentioning intake as 60 instead of 50 for B.Pharm course during the year 2018-19, based on the observations of Hon'ble High Court in orders on WP(c)no.20234,WP(C)no.22343,WP(c)no.22344, WP(c)no.25498 of 2018 ,by modifying the decision no. 49.40 of the Governing Council dated 8.11.2018
- 4. Sanction has therefore been accorded by the Hon'ble Vice Chancellor by implementing the

decision of Governing Council vide paper read (7) above to grant Continuation of Provisional Affiliation to 4 pharmacy colleges namely Elims College of Pharmacy, Villadam, Thrissur, DM WIMS College of Pharmacy, Meppadi, Wayanad, Mookambika College of Pharmaceutical Sciences & Research, Mannathur, Ernakulam and St.Johns College of Pharmaceutical Sciences & Research, Kattapana, Idukki for conducting B.Pharm course with an intake of 60 seats each for the academic year 2018-19 revising the intake sanctioned in orders read (1 to 4) above.
